**June 8, 2023**

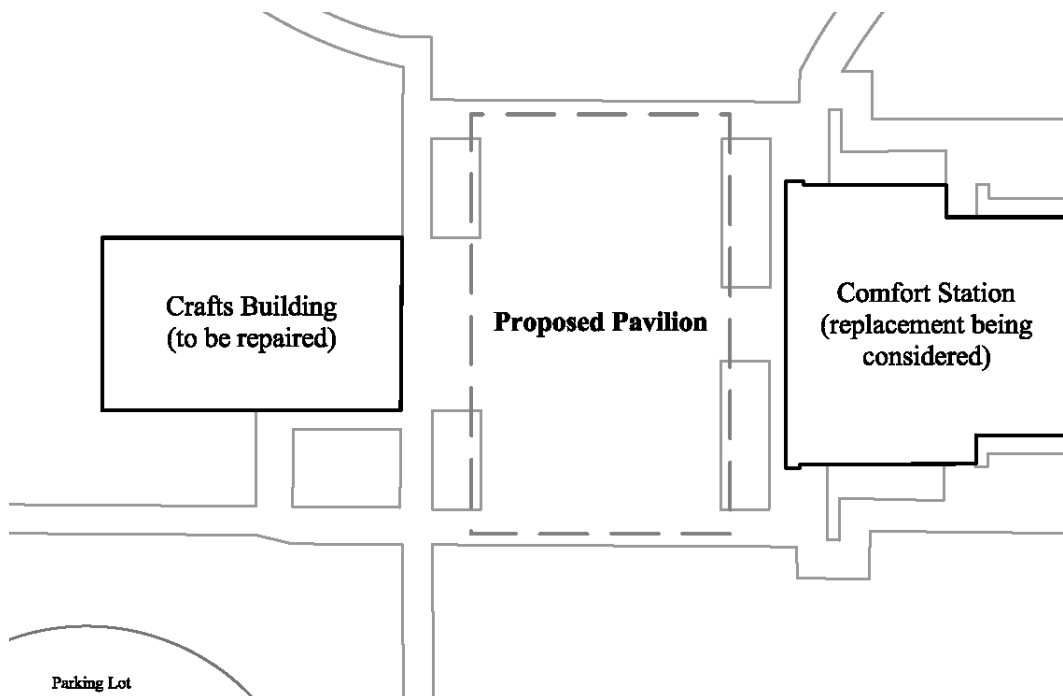
Mahalo for attending this public meeting. The purpose of this meeting is to obtain public input on the proposal to replace the former pavilion with a similar pavilion. Your input and suggestions will help us prepare a comprehensive Environmental Assessment (EA) that considers the community's ideas and addresses their concerns. Input on existing or potential park amenities is also welcome. There will be additional opportunities for input as the project progresses through the planning process.

Today, please take the time to:

- Discuss the proposed project with project representatives.
- Provide written input using the comment form.
- Complete the questionnaire.

The new pavilion would be in the same location as the former pavilion and would look very similar to the former pavilion. The remaining concrete slab would be reused. This approach will reduce or eliminate the need for ground disturbance and, presumably, reduce project costs. Important differences between the former and proposed pavilion would be that (a) modern, salt-tolerant materials would be used to extend the proposed pavilion's life, and (b) skylights would be included to improve lighting within the proposed pavilion.

In concert with the proposed pavilion, the City and County of Honolulu is also planning to repair the crafts building and considering replacing the comfort stations at the park, including the one adjacent to the pavilion's location.
