

IF YOU ARE HOMELESS AND CANNOT AFFORD TO PAY THE FEE, YOU MAY RECLAIM YOUR PROPERTY WITHOUT PAYMENT OF THE FEE AND WITHOUT A HEARING UPON ATTESTING, SUBJECT TO PENALTY OF PERJURY, YOUR FINANCIAL INABILITY TO PAY.

### NOTICE OF REQUEST FOR HEARING

The written request must provide (1) your current mailing address; (2) that the hearing is being sought pursuant to Section 29-16.3(d) of the Revised Ordinances of Honolulu as amended; (3) a short and plain statement of all pertinent facts, including a copy of this Notice or sufficient information about the removal and the property removed; and (4) a short and plain statement of the relief requested and the reasons for the relief.

YOU MAY SEEK A WAIVER OF THE FEE IF PAYMENT WOULD BE FINANCIALLY ONEROUS FOR YOU BY PROPERLY FILING AN APPLICATION (AVAILABLE AT THE DEPARTMENT OF FACILITY MAINTENANCE AT THE ADDRESS ABOVE) NO LATER THAN 25 DAYS FROM THE DATE OF REMOVAL.

UNLESS ANY CONTEST THAT IS TIMELY FILED IS UPHOLD, PROPERTY OWNER SHALL PAY A \$200 FEE FOR ALL COSTS OF REMOVAL, STORAGE AND HANDLING OF REMOVED PROPERTY.

### RECLAIMING SIDEWALK-NUISANCE

Please call (808) 768-3585 to arrange to reclaim the sidewalk-nuisance (your property). You may produce the summary removal notice for the sidewalk-nuisance or provide a description of your property and the approximate date, time and location where it was removed. All items stored by the City related to the notice (or as described) will be returned after payment of fee (or waiver or exemption from fee) and execution of a receipt attesting to ownership of the sidewalk-nuisance.

You may reclaim your property all at once or in multiple trips (so long as all your property is reclaimed within 45 days of being impounded).
