This report provides the Honolulu City Council with an update on the activities of the Office of the City Auditor (OCA) and summarizes our Fiscal Year 2018-19 Work Plan activities.

 Request for Proposals (RFP) for new CAFR contract released December 2017. Best and Final Offer (BAFO) received April 2018 and evaluated. Contract awarded to Accuity LLP in June 2018.
